ORDER

The State Govt, vide letter No. 42/164/2008-3GS-II dated 11.10.2013 & 07.11.2013 has decided to up-grade the minimum educational qualification for the post of Clerk from matriculation to 10+2 for direct recruitment as well as for promotion from Group-D employees and Restorer etc. The BOD of the bank in their meeting held on 22.11.2013 had adopted Govt. letter dated 07.11.2013. The Registrar Cooperative Societies Haryana accorded necessary approval for making amendment in Annexure-01 at Sr. No. 13 of Staff Service Rules of the Bank. Accordingly the bank had promoted 26 Peons and 08 Daftries to the post of Clerk on 24.02.15 & 11.03.16 having qualification of 10+2 as per qualification and experience required for the post of Clerk at that time.

Further, the State Govt. vide letter No. 42/164/2008-3GS-II dated 21.05.2014 has made modification that the above said Govt. instruction will be made applicable to those employees who have recruited after 07.11.2013. Sh.Nar Singh, Daftri and others Peons/Daftri have filed CWP No.20377 of 2015 in the Hon'ble Punjab & Haryana High Court that those Daftri/Peons who were matriculate before 07.11.2013 be promoted to the post of Clerk. The BOD of the bank in their meeting held on 31.08.2016 had adopted Govt. letter dated 21.05.2014. In compliance of decision taken by the BOD on 21.05.2016. The case was sent to R.C.S. Haryana for necessary approval. The Bank had prepared seniority list of Daftries and Peons and circulated on 9.05.2018. The Additional Chief Secretary to Govt. Haryana vide memo No.6047-C-7-2017/ 3884 dated 16.03.2018 has advised to comply with the Govt. instruction No.42/164/2008/3GS-II dated 21.05.2014 and allow minimum educational qualification as Matriculation in case of employee recruited before 7.11.2013 and 10+2 in case employee recruited after 7.11.2013 for promotion to the post of Clerk from Group- D employees.

In view of the above, the names of Daftries/Peons alongwith petitioners S/Sh. Nar Singh, Subhash Sharma, Rohtash Sharma, Rohit Sharma, (Daftri) and Sh.Dharampal, Mohna Ram, (Peons), who are eligible for promotion as per seniority are being considered for promotion to the post of Clerk from the post of Daftri and Peon respectively as per seniority list Daftri/Peon. The names of rest of petitioners i.e. Daftri/Peons will be considered in due course of time as and when the promotional post of Clerks are available.

Accordingly, the following Daftries/Peons are hereby promoted to the post of Clerk in the pay Band of Rs.9300-34800 with Grade Pay of Rs. 3600/- with immediate effect:-
